**NOTIFICATION FOR ENGAGEMENT OF APPRENTICES UNDER APPRENTICES  
(AMENDMENT) ACT, 1973.**

The Director, ICAR – National Research Centre for Banana, Thogamalai Road, Thayanur Post, Tiruchirappalli – 620 102, Tamil Nadu (STNTCC089613) Notification No. 01/2023 dated 31.10.2023 from eligible Graduate / Diploma holders in Science / Engineering (passed out during 2020 / 2021 / 2022 / 2023), for undergoing one year Apprenticeship training under the Apprentices (Amendment) Act 1973.

**I. Category: Graduate & Technician (Diploma) Apprentices:**

**II. ELIGIBILITY:**

Qualification: Bachelor of Science / Diploma passed (in the years 2020, 2021, 2022, 2023 only) and who have registered in MHRD NATS Portal ([www.mhrdnats.gov.in](http://www.mhrdnats.gov.in)), which is mandatory.

Candidates who have previously undergone Apprenticeship or presently undergoing Apprenticeship Training or presently in employment elsewhere being registered for Apprenticeship Training under Apprentices (Amendment) Act 1973, are not eligible to apply.

**III. MINIMUM EDUCATIONAL QUALIFICATIONS:**

**Category – I Graduate Apprentices:**

- A Degree in Botany granted by statutory University.
- A Degree in Biotechnology granted by statutory University

*RL*

- A Degree in Food Processing & Preservation granted by statutory University
- A Degree in Computer Application granted by statutory University

**Category-II Technician (Diploma) Apprentices**

- A Diploma in Agriculture / Horticulture granted by statutory University
- A Diploma in Nursery Management and Ornamental Gardening granted by statutory University

**IV. AGE:**

Age limit will be followed as per Apprenticeship rules.

**V. RESERVATION OF VACANCIES:**

Guidelines under Apprentices Act Reservation for SC/ST/OBC/PWD will be followed. The aspirants who are claiming reservation under SC/ST/OBC/PWD shall provide certificate, as per Government standard format, failing which their claim for reservation will be considered as 'General' category only. If BC candidates claim in OBC category, they should furnish OBC certificate, as per the Government prescribed (OBC) format from the certificate issuing Authority / Tahsildar (if authorized).

**VI. MINIMUM PHYSICAL STANDARDS:**

As prescribed in Clause 4 of the Apprenticeship Rule 1992, and amendments thereof, if any.

**VII. DURATION OF TRAINING:**

The duration of Apprenticeship training will be for a period of ONE year as per Apprentice (Amendment) Act 1973.

**VIII. PREVIOUS TRAINING / EXPERIENCE:**

Candidates who have already undergone or currently undergoing Apprenticeship under Apprentices (Amendment) Act 1973 or having one year or more experience are not eligible to apply.

**IX. SELECTION PROCEDURE:**

**MODE AND CRITERIA OF ENGAGEMENT OF APPRENTICES:**

- Engagement of Graduate and Technician Apprentices will be purely made on merit basis of aggregate marks obtained by the candidates in Graduate and Diploma respectively.
- Preference will be given to the children of VPA Employees i.e. the children of deceased employees/medically invalidated & superannuated employees / serving employees respectively.
- The final rank list would be prepared according to categories General / SC / ST / OBC / after certificate verification comprising of ADT BoAT (SR) and Officials ICAR – NRC for Banana, Tiruchirappalli, Tamil Nadu.
